Sheep: excellent progress visiting Lansdown Cres for site survey & info gathering with resident "sheep minder" Michelle Maguire; FB & JML have reviewed legal docs, licences etc and made inroads with the Estates Dept. There is still a lot to consider and work through, including consultation and land clearance, when the time is right

3. Camden's Covid-19 Volunteer Support Activity Initiative

- a. Current status: we now have 56 volunteers on our database 11 are active in helping with shopping, pharmacy or phone call support; others are helping neighbours on an informal basis. Last week we officially joined the Bath-wide initiative managed by 3SG, which provides a co-ordinated and professional response to any caller in need. Once triaged by type of need, a call comes through to JL or LC to match with a volunteer, called a "street champion". This has required asking volunteers to register with 3SG. Currently the call rate is not too high & LC and JL are managing it satisfactorily between them, although more support may be needed in time
- b. Accountability and liability: JL reported his general concerns around this. There is some limited cover available now through 3SG, once volunteers are signed up
- c. The initiative is being very well received; if nothing else this emergency situation will have brought people more into contact with each other than before and strengthened our community awareness and spirit. As a committee we can build on this to everyone's benefit when times are easier. Agreed
