3.	 LN sub-group update 3.1 JL reported that the decision on which the LN proposal will be adopted as policy has been delayed until the Cabinet meeting on 9th December. At some point after then, there will be an invitation to ward councillors to prepare and submit their proformas. These will then be assessed and the selection of which bids go through to trialling will take place after that – perhaps in January 3.2 JL outlined the Work Streams that the group are working on (as per doc sent), showing the extent of considerations and actions underway; a few clarification questions raised - all actions acknowledged and accepted 3.3 Decision taken to refer to the initiative as "Liveable Neighbourhoods" rather than "Low Traffic Neighhoods" from here on, both to give consistency and to maintain focus on the wider LN strategy; it's not just about traffic reduction but also RPZs and electric vehicle charging points.
